Poor countries cannot guarantee human material rights, forgot ting that democracy, just like any doctrine is a cultural thing that aims at serving a certain purpose or purposes and "cannot be captured in one model that fulfills the same functions and provides the same meanings across the societies". If you ask African rulers the essence of democracy, they will tell you that it is about the government elected by the majority. These are among the questions ruling elites and their citizens did not ask, ponder on and after introducing the concept of democracy, let us now look at some important issues pertaining to democracy, specifically its definitions and meaning.

The major question readily asked is: Who defines this means that academics, especially African academics, in whatever field(s) in crafting their definitions. If we are to apply such a rationale, let us say in questioning the definition of democracy, the lack of right answers to democracy gave Europe yet another chance to rule Africa indirectly by making sure that democracy is used to their advantage. Thus the definition and meaning of democracy, According to Enslim and Horsthemke (2004) Maintains that "democracy is notoriously difficult to define, the meaning of democracy has remained and probably will always remain, unsettled. African democracy is distinct and unique which makes sense without using the lenses of superiority and duplicity that the Europeans has always superimposed on others.

Europe Killed African democracy in other to give room for its own brand of democracy that serves it but does not serve Africa. If democracy is supposed to be unique but not homogenous due to

the Fact the needs of Countries and traditions differ according to time, this brings us to the natural African democracy that existed before the introduction of flimflam and harmful Western democracy. Ironically, while Europe has always made Africa to believe that it is how to deliver Justice to the Majority in Africa, it is just a typical system that is there to make Africans believe that they are now at Par with Europe Politically while they are not. For Europe, it is how the majority can call rulers to account. This is because democracy has different meanings and uses between Europe and Africa.

### How Africa's Underdevelopment Became a Myth to Save Europe

The problem here is that impoverished African governments can't invest enough money into health care, education, infrastructure, etc. This kind of problem is widespread in the continent today, which causes underdevelopment in Africa. Many African governments have implemented policies that prevent the continent from developing. This is because African countries often lack the resources needed to govern themselves effectively.

It is estimated that 60% of the African population is between 15 and 24 years old, which creates a 'youth bulge. 'This means there are many young people in Africa today. This causes severe social problems because young people become frustrated when not develop their lives. This frustration grows when they see other people succeeding without working hard, which means enormous pressure on some individuals to succeed in Africa today.

Most African countries have an insufficient infrastructure. The lack of infrastructure in Africa today is a big obstacle for development because it limits people's ability to do business across borders. This means there are fewer opportunities for work, which leads to unemployment and poverty throughout the continent. Many countries in Africa also have problems with teachers who are not adequately trained or paid enough money. Illiteracy is common in Africa today, limiting the development of people throughout the continent.

### VII

### How Aid Became another European Hypnotic Tool in Africa

Central to the development of European countries is the slave trade; hence Africans were myopically robbed of her human resources. The role of the African man toward the industrial revolution of the European country cannot be over emphasized hence there cannot be fire without smoke, that is, Africa was the sole propeller that made the revolution a success for they (Africans) worked while the Europeans sat down comfortable to design machines that will take over from the manual indulgence by the blacks in order to hasten their productions. Furthermore, we cannot holistically project the role of Africans to the westerners without engaging in the unruly act of colonization and neocolonialism.

As such, Soyinka cited in Ojo (2015) concurs with Mhango maintaining that Africa became underdeveloped due to "the twin evils of slavery and colonialism inflicted by the Western world" (109); also see Koivula (2006); and Nunn (2008); Arowolo (2010); and Mhango (2017) who, as well, argued that the introduction of slavery and colonialism gave Europe an advantage to develop while Africa underdeveloped. Nunn and Puga (2012) answer the question by maintaining that "the slave trade had adverse effects on subsequent economic development because they weakened indigenous political structures and institutions, and promoted ethnic and political fragmentation" (2). How can the thug's definition of development define mine accurately while it means my underdevelopment? It is hypocritical and a big lie; to allow and expect criminals who colonized enslaved and robbed Africa to justly and judiciously define development for their victims, in particular at the time their crimes are still committed by extension under whatever system and doctrine such as co-liberalism, globalism, capitalism; you name it. D) Trade and development has estimated that each migrating African professional represents a loss of \$184,000 to Africa, and the financial cost to South Africa is estimated as \$37million. Thus historically records show that Africa did trade with Asia many years before Europe became aware of it.

Unequivocally, the decadences caused by the European to Africa are quite numerous hence we cannot limit the role of Africa to westerners to just; the source of raw materials, colonialism, and neocolonialism but also to the academic realm. Before colonialism, Africa believed and depended on the help of western countries, for a long African countries have depended on foreign aid. As developing countries without enough resources of their own, African countries inevitably need additional aid resources. Africa's long reliance on foreign aid has emanated in part from the advice of its development partners.

Africa's dependence on foreign aid, however, comes with costs. Aid resources have not matched Africa's vast development needs, particularly relating to building physical and human capital. Aid has increased the continent's indebtedness whose high servicing costs have diverted resources away from development and social projects. Bureaucracy and volatility in aid delivery have often curtailed or frustrated African development budgets.

Further, aid tying in the form of forced purchases from supplying countries and imposition of policy conditionalities, has often not served the interests of African countries. Africa's long dependence on foreign aid has created moral hazard by breeding complacency and apathy in seeking alternative sources of mobilizing development resources. The domestic capital market can provide long-term funds for the budget and other developmental activities in the key sectors of the economy. Aid has not only been inadequate for Africa's development needs, but it has also been unpredictable and volatile, frustrating African countries' budgets.

Aid has created large indebtedness for Africa, the servicing of which has entailed considerable costs. Further, aid tying in the form of purchases from donor countries and imposition of policy conditionalities has not always served Africa's interests Many African countries have low incomes. It is sad but true to say that few African countries cannot leave without foreign aid not because such African states are not self-sufficient but because they have been lackadaisical and myopic in their understanding to decipher that aid is one of the major feathers of the wing of neocolonialism.

# VIII How Europe and Vatican Colluded In Robbing Africa

And just like for-profit behemoths, they are willing to wield their power and wealth in the service of self-perpetuation; even it harms society at large. In fact, unbeknown to religious practitioners, harming society may be part of a religion's survival strategy.

### IX How Can Africa Heed Its Wake-Up Call

The African economy remains underdeveloped despite decades of conceptualizing, formulating and implementing various types of economic policies and programmes, the African region contains a growing share of the world's absolute poor with little power to influence the allocation of resources. These include: the 1980 Lagos Action Plan; the 1986-1990 Priority Programme of Economic Redressing of Africa (PPREA) adopted by the OAU in 1985 and the complementary UN Programme for the Economic Redressing and Development of Africa; ECA Alternative Structural Adjustment Programme for Africa: and the African Scope of Reference for SAPS for Socio-Economic

Redressing and Transformation. This paper aims to show how the combination of peace, good governance would lead to economic transformation and wise up of call for African countries to wise up.
